To do this, the Supreme Court established a requirement that schools take the following actions: To respect and protect the right of free speech as an educational value. To provide a safe and secure learning environment for all students and school staff. It is the job of the school administration to make sure that students, faculty and staff learn in a safe environment. We have therefore reviewed this procedure and are revising it. Earlier this year we informed parents and students that the new policy was being revised and explained the current situation. We have also been working closely with the Minister for Education to address this important issue and we are pleased to be able to announce our revised policy. It is the duty of all concerned, as specified under Article 9 of the Constitution, to preserve and promote national and regional identities and cultures; to safeguard, protect and develop the educational system; to provide for the general well-being of the citizenry; to foster social justice and economic and social development, and to safeguard democracy and the Rule of Law. The purpose of the Irish Constitution is to ensure that Ireland remains a democratic, multiethnic and multi-national state in which national and regional identities and cultures can be preserved and in which the unity of the people is preserved. The Constitution guarantees the protection of the national and regional cultures, traditions, institutions and language of the people of Ireland. The Constitution also guarantees freedom of the media, freedom of expression, freedom of religion, and freedom of assembly. The Constitution ensures that the rights of the citizenry are equal and are fully protected by the State. A democratic state is one that is responsive to its citizens, based on the rule of law, committed to values that reflect those of its people, and respects and guarantees the rights of all citizens, including those who are not born in it, their culture, religion, traditions and institutions. Ireland is a democracy with a constitutional system of government. In a democracy, the majority has the right to rule, but the basic rights of everyone must be respected, including the rights of those who do not share the political beliefs of the majority.
